**Team crest:** The team crest samples are available on the website, but the concept has been tabled for now, considering the recent discussions of a three-club merger with Metro and York Premier.

**Honor Roll members sought:** The club is attempting to assemble at York United College Honor Roll to be listed on the website, detailing all former players who have played or are currently playing collegiate soccer. Anyone with information should contact Tim Holden.

**New Uniform designs:** Chris Hoover of Angelo's Soccer Corner brought several new uniform designs to the meeting. The club is deciding on a new style beginning with the fall 2007 season. The club was leaning toward a style that offers both men's and women's shorts sizes with different cuts for each. Also taken into consideration will be the duration the style will be offered (at least 3 years is the minimum being considered). The current cost for a uniform is \$45.50, but the new cost could be slightly higher than that, particularly if off jerseys will be added, rather

than t-shirts. The styles were discussed, and a vote may be taken on a new style as early as the February meeting.

**Tryout schedules needed:** All teams are asked to submit their tryout schedules for addition to the website by February's meeting, at the latest. If you know when you will be holding tryouts, please e-mail them to Tim Holden so that they may be added to the list. This is critical for advertising for new players as well as for scheduling fields to hold tryouts.

**Field availability:** All teams planning on playing home games at Penn State York should submit their schedules to Rich Chilcoat ASAP. These games must be coordinated according to field availability, as well as with other United teams playing there.

**Field "payments":** The club decided to make \$200 "good faith" donations to York Country Day School and Christian School of York for their parts in providing fields for teams to use. YCD has provided practice time and CSY has maintained the Cousler Park fields, keeping them lined for games.
